How Workiva AI works



User inputs are filtered to adhere to guidelines, eliminating off-limits requests

Boundaries are set for generating responses, using factors like context, intent, and persona. As a result, responses generated are more relevant and aligned with your need.

We leverage embeddings and retrieval augmented generation (RAG), consider the solution and file type being used, and offer templates for specific Workiva-exclusive extensions, such as Workiva Support or ESG European Sustainability Reporting Standards content. We also provide citations and references for responses, indicating their source.




Prompts and model parameters create a user-friendly experience—including predefined commands like “shorten” or “elaborate,” as well as prompt-tuning with industry terms to avoid confusion (e.g. 10-K report vs. 10-K run)

Reports are generated based on advanced AI models from industry leaders such as Google, Microsoft/OpenAI, AWS/Anthropic.
