Recent innovations in Workiva AI are transforming the intelligent companion into a seamless and intuitive collaborator, deeply aware of your work to help you accomplish critical tasks with greater speed and precision. This deep contextual awareness allows it to provide personalized recommendations based on your open document, help you build and fix SQL queries in Wdata, and even automate inspection of your risk and control program to identify gaps or overlap. As a major new enhancement, the intelligent companion is also gaining access to third-party data sets, with ESRS intelligence being the first to provide more specialized assistance with peer benchmarking, research, and disclosure drafting and alignment.

Planned innovations for later this year will strengthen collaborative agentic augmentation with features specialized

for solution-specific workflows. For finance teams, features like SEC filing intelligence will accelerate insight generation and narrative drafting. Audit and risk teams gain a suite of new solutions designed to accelerate tasks like control creation and documentation, with features such as the flowchart visualizer that can translate written content into a visual workflow with a single click. And sustainability teams gain ISSB intelligence that will provide users with insights and disclosure alignment to new standards.

As we look ahead to future innovations in 2026, you can expect to see the continued maturity of our AI strategy with a significant move toward increasing specialized automation with reinforced human oversight. We will expand our agentic ecosystem with additional extensions and agentic experiences that will include automated benchmarking and validation capabilities for SEC reporting and disclosure generation for compliance with financial reporting and sustainability regulation and requirements.
